#### **Transport by Airfreight (Valuable Cargo)**

Besides the possibility of handcarry it is also possible for you to send your shipment by airfreight to Munich.

We recommend one of the following airlines

- 1<sup>st</sup> priority Lufthansa Cargo (Routing via Frankfurt)
- 2<sup>nd</sup> priority Swiss Cargo (Routing via Zürich)
- 3<sup>rd</sup> priority K L M (via Amsterdam)

Other airlines must be checked and confirmed by Brink's Munich before sending a shipment !!!

- Name of the contact person at the show, passport copy and mobile phone no.

Brink's employee will assist you on your way to customs.
